#### MBA PRESIDENTS'S REPORT





**Spring 2019** 

The convention was lots of fun; thanks everyone for attending. The inclusion of the CHC components were also very productive; I hope other members from Manitoba had a chance to meet some of the CHC delegates from across Canada. The CHC meetings the night before included some interesting speakers on expanding in the new foreign markets and experiences as well as programs like the EDC(export development Canada) for those seeking new markets. I enjoyed the excellent speakers and was interested with the specific comments from Peter Awram and how they may relate to the strong resolution passed by membership to pursue stricter accredited methods (like NMR) for honey testing.

The following MBA meetings have been ongoing: meeting with Miles Beaudin (director for MB Ag), implementation of Strategic plan, and introduction of the new SFCR program

Our meeting with the Ag director was very successful and I expect Ian will share the intricacies of that meeting,

We have fully approved the new Strategic plan and are excited to see its implementation as an excellent guiding document for those in the director positions. Understanding the role of the association to lead and place everyone in a good position to do the best they can with their described duties will make our organization run smoother.

Manitoba has acquired the SFCR(safe food for Canadian regulation) guidelines outlined by Beary Berry in Alberta. The program must be implemented in the 2019-2020 year for all those who have a food handling facility and plan to export/interprovincial sell honey in excess of \$100,000. Getting the program came with some negotiation and is the same framework being given access to (ABC)Alberta Beekeepers Commission, (SBC)Saskatchewan Beekeepers Commission, and BeeMaid members. The program has been reviewed and although may seem a bit redundant will be required once your standing CFIA certificate expires. The Beary Berry guidelines were put to the test under the new regime of SFCR and passed within tolerances. The expectation is that each individual operation will be given these documents to work with and if they are within your current Food Safety Program already then you may not have to make any changes to your program. Reading through the guidelines will enable you to determine a close adherence. Those who simply take these documents and pin them to the wall without adhering to program definitions may find they are in violation of the new SFCR program. You will also have to setup an account with SFCR and provide a number of details in the my CFIA web ap.

Honey prices remain low; numbers I have heard quoted range from \$1.80 to \$1.55 CAD FOB.

We currently have no beekeepers picnic/ field day planned, however we are planning a workshop for the fall (possibly Nosema testing) if everything goes as planned.

Members should have got an email blast for a collaborative effort by the MBA and BeeMaid to offer a session on the implementation of the Beary berry SFCR program. The first sessions happening in April and for those who miss out on the sessions this spring we will have another implementation session in the fall.

Serious concerns over the Africanized honey bee in California may threaten our supply of queens should Health Canada determine that there is a biohazard risk associated with that region. Certainly the efforts of MBA to access Chilean sources fit our model of effective alternatives going forward. I would encourage everyone to keep an ear to the ground on this topic and perhaps consider alternative sourcing to improve the market potential going forward.

# **PUBLIC NOTICE**INSECTICIDE USE PROGRAM FOR 2019

The City of Winnipeg's Insect Control Branch is involved in the control of nuisance and disease carrying mosquitoes in the City of Winnipeg and up to 10 km beyond.

Some of the control methodologies that are employed will involve the use of Deltamethrin®. However, to protect bees from potential toxic effects of this control product, a 90 metre pesticide free radius will be provided around all registered honeybee and leafcutter bee colonies within City limits (300 metre radius for colonies outside City limits). Beekeepers are encouraged to participate in this program by advising the Insect Control Branch of bee locations.

For further information, please call 311 or write to the Insect Control Branch, 3 Grey St., Winnipeg, MB, R2L 1V2. An appointment can be arranged with Insect Control staff to properly map beehive locations, ensuring appropriate buffer zones around your colonies.

# MBA meets with Manitoba Agriculture

On March 14th, Ian Steppler (director) and Daryl Wright (Secretary) of the Manitoba Beekeepers' Association sat down with Miles Beaudin, Director of Primary Agriculture Manitoba Agriculture and Rheal Lafreniere, Provincial Apiarist for a full day meeting around our industry support, growth and development.

This was our second meeting with Miles in regards to a number of industry objectives the MBA has set out as priorities to protect and to move our Beekeeping industry forward. There was a lot accomplished during this meeting! Our provincial disease inspection service has been negotiated for a 3 years term with further investment into the program to help achieve our 5% target. This will ensure our commercial operations are adequately covered and it will provide the flexibility for Rheal to administer the program to include smaller hobby type beekeepers into the program. We are extremely happy to have this program in place again and to have the increased investment to adapt this program to recognize our changing industry dynamics. This service has been identified as important to all commercial beekeepers.

The Manitoba Beekeepers Association has been negotiating extensively to bring honeybee diagnostic services back to Manitoba Beekeepers. Details are still getting ironed out by Rheal but it appears that we will have access to AFB, rAFB, EFB, varroa, Nosema and viral analysis (DWV, KBV, IBPV) analysis as a cost recovery service. The Broad-spectrum Honey Bee Diagnostic Service will be administered through the Veterinary Diagnostics Services with collaboration from the U of M and run as a satellite service of the National Bee Diagnostic Center. Processing of samples are expected to begin Mid May. For more information on how to collect and submit samples contact Rheal Lafreniere 204-945-4825, email Rheal.Lafreniere@gov.mb.ca.

With the resignation of David Ostermann, our provincial pollination specialist, we have been lobbying hard to ensure our industry does not fall short on support services if the position gets cut due to attrition. This position is important to our industry as not only does it provide our industry with needed support services, it acted as the function of succession planning around our Provincial Apiarist. It is important that our industry have the proper function around providing transitions between these positions so that the interruption of support doesn't fall to the determent of beekeepers.

Within our lobbying efforts and negotiations there have been discussions around "thinking outside of the box" and to evolve our industry services to better serve and bring more value to our honey bee industry. There is a willingness within government to help support the efforts of industry to develop industry support programs which move towards self reliance, sustainable efforts and better value to the tax payer, industry and to producers. As has been clearly stated as a top priority within our strategic plan document, our industry wants to develop a Technical Transfer Program.

We have requested the development of a technical transfer program to serve our Manitoba Beekeepers. A service that would work at arms length from the government and arms length from the association to work directly with beekeepers on extension, research and any such activities needed or supported by Manitoba Beekeepers.

From direction given to the MBA at the AGM from our membership, Rheal has developed a proposal to hire in a consultant to help draft a feasibility study/ business plan for the development of a Technical Transfer Program. As it's developed, we plan on using the direction from our membership (survey monkey) to identify objectives and priorities that are important to Manitoba Beekeepers and develop the Tech Transfer Program to best suit OUR Manitoba beekeeping needs.



What might this program look like? The program would be developed through stages which would focus on the priorities of Manitoba producers (survey monkey). Perhaps it would establish closely within the U of M entomology department to bring a strong research component which would secure its base. Have this position work directly with beekeepers on extension by collaborating closely with other TTP nationally and internationally to bring better management practices back to Manitoba beekeepers and help promote the application of all this available academic knowledge into something actually tangible and useful to Manitoba beekeepers. More tools in the hands of Manitoba Beekeepers! This is a conversation I think we need to elaborate on as we move forward on the creation of this

project. I would suggest we have an open conversation between beekeepers, within associations, to Rheal Lafreniere and to the the MBA so we can collaborate in the development of this project. With all of our association development efforts through the department of Manitoba Agriculture, our province is as close as ever in finally getting this kind of service to our beekeeping industry!

Energy and dedicated drive is a group or association's most precious resource. Without it, that group or association has nothing. But with it, everything happens. It's fun to feel that dedicated energy within our Manitoba Beekeeping Industry!

#### MANITOBA AGRICULTURE EXTENSION REPORT

#### Rhéal Lafrenière Provincial Apiarist

#### **Honey Bee Inspection Program**

Manitoba Agriculture is in the process of finalizing the contract for the Honey Bee Inspection program. At the time of writing this article, the Request for Quotation (RFQ) (a.k.a. tendering of the contract) was in the process of being published and the anticipated start date for the successful contractor is set for May 1, 2019. The contract will be for a period of two (2) years concluding on April 30, 2021. There will be an option to renew for one (1) additional option year, ending April 30, 2022.



The proposed contract will be to inspect 4% – 5% of the honey bee colonies in the province (i.e. between 5,000 to 6,000 honey bee colonies per annum). The focus of the inspection will be AFB/EFB inspection. Manitoba Agriculture will provide the Inspection Service Contractor (ISC) with the Inspection Priority List, which will identify the number of apiaries and colonies to inspect per honey bee producer. The ISC will be responsible for selecting which apiaries and which colonies to inspect for individual beekeeper. The Inspection Priority List also includes contact and location information, which will be used by the ISC to coordinate inspection appointments with producers. The Inspection Priority List provided to the ISC will divide the province into four (4) beekeeping regions: Northwest, Southwest, Eastern/Interlake and Central, which includes Winnipeg. Each region will have a list of honey bee producers that should be inspected that year. Producers wanting to be inspected that are not on the priority list will be inspected outside of the contracted service agreement. The inspection need to be coordinated through the Provincial Apiarist's office.

The ISC will be responsible for coordinating the collection and analysis of the samples deemed necessary, including but not limited to dead bee larvae, adults and brood comb suspected to be infected with any of the regulated diseases. The ISC will also be responsible for filing the inspection and diagnostic results with Manitoba Agriculture as well as reporting the inspection results to the respective producers.

The ISC and all of the employees or subcontractors employed by the ISC to conduct honey bee inspections will be appointed as bee inspectors under *The Bee Act* and as such are empowered with the "Powers of Inspectors" as outlined in the Act.

#### Powers of inspectors:

An inspector may, at all reasonable times, and upon presentation of a certificate or other means of identification as prescribed in the regulations, for enforcing this Act and the regulations

a. Without a warrant, enter any place or premises, other than a dwelling, in which any bees or beekeeping equipment are kept or in which the inspector has reason to believe bees or beekeeping equipment are kept for the purpose of inspecting or examining the bees or beekeeping equipment;

b. Without a warrant, stop any vehicle in which bees or beekeeping equipment are being conveyed, or in which the inspector believes on reasonable and probable grounds any bees or beekeeping equipment are being conveyed, and conduct such inspections as may reasonably be required for purposes of this Act;

c.Require the production of any documents, books or records that relate to the keeping or sale of bees or beekeeping equipment, or that the inspector has reason to believe relate to the keeping and sale of bees or beekeeping equipment for inspection and may make copies thereof or take extracts there from;

d.Inspect any bees or beekeeping equipment; or

e.Where reasonably required for purposes of this Act, take and retain any bees or beekeeping equipment as samples for test purposes.

Power of Inspectors will be granted to the ISC and employees or subcontractors conducting inspections until the end of the Contract or until the individual inspector ceases to be involved in the Contract.

#### **Apiary Signage:**



This inspection season, bee inspectors will be handing out warning notices to all beekeepers that do not have signage at their apiaries (a.k.a. beeyards) that comply with the minimum requirement outlined in The Bee Act.

• Every person owning or operating an apiary shall erect and maintain at the site of the apiary a sign clearly stating the name and address of the registered beekeeper. It would also be beneficial to include a contact phone number.

**Honey Bee Diagnostic Services** 

Manitoba Agriculture has been consulting with the Department of Entomology at the University of Manitoba and the National Bee Diagnostic Centre (NBDC) in Alberta to get their assistance on re-establishing honey bee diagnostic services in Manitoba. The U of M has provided advice on methodologies for molecular testing for several common honey bee viruses (e.g. DWV, KBV, IAPV, and BQCV) as well as for nosemosis.

The NBDC has agreed to provide advice on the methodologies and protocols for culturing and PCR analysis of economically important bacterial diseases, such as AFB and EFB. At this time, the assistance provided by NBDC has been primarily in the form of advice, but NBDC is in the process of developing an MOU to formalize the relationship. Once the MOU is in place, NBDC will share detailed testing protocols. In addition to providing methodologies and protocols, NBDC will also provide MB Ag with positive controls (PCs) and training for staff.

With the exception of varroa mite analysis, Veterinary Diagnostic Services staff at the Ag Services complex will be managing the honey bee diagnostic services program. Crop Diagnostic Centre staff at the Ag Services complex will be conducting the varroa mite analysis. Veterinary Diagnostic Services is expected to be able to receive and process samples starting in mid-May. The National Bee Diagnostic Centre is able to receive and process samples at anytime. #### Manitoba Beekeepers Association Trade Mission to Chile - Daryl Wright



During the past several months the MBA Directors have worked towards arranging a Trade Mission to Chile. Discussion at the Board level has determined that there are real opportunities for the industry to work more closely with the Chilean Ministry of Agriculture and beekeepers in Manitoba and Chile to the betterment of the Manitoba Industry.

Over the years, New Zealand and Australian gueens supply has been decreasing and there does not appear to be much interest from these countries to increase supply to Canada. The spread of Africanized bees in the US have also caused many Manitoba beekeepers to be more cautious about importing queens from California and Hawaii. Currently Hawaii is regarded as the premiere supplier of queens in Canada. The concern now is that it is important to diversify the sources for gueens to reduce the risks of dependency on one single supplier.



Manitoba has a growing demand for Canadian produced honey bee queens, but the demand for import queens is still very high and cannot be ignored. Last year over 30,000 queens were imported to Manitoba and over 250,000 queens nationally. In order to produce the best imported-stock for the honey bee industry, we should be requesting to have more Canadian genetics in our imported gueens. Chilean gueen breeders have expressed interest in incorporating Canadian honey bee genetics into their breeding program. Having high quality import stock would not only benefit Manitoba beekeepers that import queens but would also provide greater genetic diversity of quality drones for open mating with local Manitoba queens.

Two of the objectives of this Mission are to:

I visited Chile from December 2 to 7. From the various meetings with government and Beekeeping specialists, there was great anticipation and interest in improving the trade between our countries with respect to a quality and consistent product. Beekeepers that I met were also in agreeance that providing a queen that would be beneficial to our climate would help their trade and also genetic stock in their operations.

What are the next steps? There are many. Applying for CFIA and SAG to import bee genetics to Chile will be one step. We must show that are genetics are disease and pest free so testing. Once we are able to export Canadian genetics to Chile, distribution, artificial insemination and kept in a controlled environment are all factors that must be considered. Once the product is imported to Canada, testing must occur to ensure the qualities we select are present. Discussions have included future meetings during Apimondia in Montreal and visits from Chilean beekeepers to Manitoba.

This will not be a short term project but the supply of known genetic queens for producers will be a benefit. This can also be a benefit to queen producers in Manitoba.

The MBA wishes to express our gratitude to Arturo Gardeweg, International Business Development, Manitoba Trade and Investment and Rheal Lafreniere, Manitoba Agriculture in developing and communicating to the government officials in Chile our desire to work with them to benefit the respective industries.

BE IT RESOLVED that the MBA urge the CHC to continue to lobby CFIA for stricter accredited methods for testing of all imported honey, using the most modern methods (e.g., NMR testing) available.


